Advisory: Online education session on B.C.'s Human Rights Code will explore housing, employment and services

Vancouver B.C. – Continuing its successful series of educational sessions, BC's Office of the Human Rights Commissioner will be hosting another free public session on B.C.'s *Human Rights Code* on Jan. 25, 2024. This 90-minute virtual exploration will dive into three key areas covered by the *Code*: housing, employment and services.

Whether tuning in as a landlord, tenant, employer, employee, service provider or service user, each participant will learn about their rights and responsibilities under the *Code*. By the end, learners will be able to:

- situate B.C.'s *Human Rights Code* within other human rights laws
- recognize terms used in B.C.'s human rights system
- identify discrimination under B.C.'s Human Rights Code
- recognize what protected personal characteristics can be used to make human rights complaints
